Background Information The TCAC-G program, consisting of the AN/UYQ-83B TCAC Remote Analysis Workstation (RAWS) and AN/MYQ-9B TCAC Transportable Workstation (TWS) is capable of directing and managing the technical and operational functions of Radio Battalion (RadBn) Electronic Warfare (EW) assets and providing communications connectivity for data exchange with these systems. The system provides ground processing of EW information, including Electronic Warfare Support (ES) and Electronic Attack (EA) data collected by the RadBns and Tactical Electronic Warfare Squadrons (VMAQ) EA-6B aircraft. The system is capable of correlating, fusing, and evaluating radar emitter identification and location data from the EA-6B with other National and theater sources.
