Charts were annotated on a daily basis by the Commander Caribbean Sea Frontier Movement Report Center Watch Officer to show the position and direction of all U.S. and foreign naval vessels in the Caribbean area.</p> <p>Charts are full size, i.e. 35 inches by 39 inches and are rolled. There is one chart for each day in calendar years 1959 and 1960.</p> <p>The records were originally retired by COMCARIBSEAFRON-Operations, NAVY 116, FPO, NY to Navy Records Management Center, Algiers, Louisiana on March 8, 1961.
