Background Information Naval Reactors is solely responsible for safe nuclear operations, among other things, pursuant to 50 USC §§ 2406, 2511 (codifying Executive Order 12344, February 1, 1982). Shipboard letters to Naval Reactors Headquarters Commanding Officer's Letters and Operational Reactor Safeguard Exams are validation of this authority and safe nuclear operations. These supporting records are needed through the term of any liability period for the combatant sailor and his first-generation descendent. NARA approval will allow records from 1980s forward, previously archived inappropriately as Permanent, to be recategorized as Temporary with eventual destruction.
