	<p><u>Background:</u> The purpose of this record schedule is to address issues within SSIC 5813, Courts-Martial Trail Records. SSIC 5813, paragraph 1 is currently uncheduled. The proposed schedule assigns a disposition decision for this paragraph. It also rearranges the remaining portions to provide a more logical structure that will provide more clarity for the user. It also provides a disposition for finding aids associated with the General and Special Courts-Martial Records.</p> <p>Currently, there are 14,638 cubic feet of General Court-Martial records stored at the Washington National Records Center. It was recently learned that the National Archives has accessioned all General and Special Courts-Martial from 1799 to 1942. The precedent established by the National Archives is captured in part by the recommendation contained herein.
