Background Information **Neurocognitive Assessment provide Military Health System (MHS) personnel access to a continuous and coherent chronology of the neuro-cognitive health status of a United States Military Service Member that can be used in evaluating treatment of Traumatic Brain Injury (TBI) and for assigning further psychological health care. The system will enable care providers to initially assess warfighters in order to determine a baseline neuro-cognitive assessment and to use a comparative assessment should injury occur.**

1	<p>Neurocognitive Assessment Performance Report Data background Prior to decommissioning the TRICARE Management Activity (TMA) Neurocognitive Assessment Tool (NCAT) in October of 2012, the agency produced a limited number of baseline neurocognitive assessment performance reports on military service members from the system to test the viability of the NCAT as a solution for evaluating the treatment of concussions, traumatic brain injury (TBI), mild Traumatic Brain Injury (mTBI) and for assigning further health care. The intent of the neurocognitive assessment performance reports was to compare the data against military service members' post-injury assessments and provide de-identified information for research and to aid in the detection/diagnosis of mTBI and TBI. TMA did not fully deploy the NCAT and officially decommissioned the system in October of 2012. The agency will transfer all neurocognitive assessment performance report data to the NARA Temporary Records Information Portal (TRIP) for the duration of the records' lifecycle.</p>
