Item 14 was, per Ted Hull of the Center for Electronic Records, ultimately reappraised as of temporary value and destroyed.

Item 15 was accessioned by NARA and is described in National Archives Identifier 604413.

Item 16 was accessioned by NARA and is described in National Archives Identifier 613892.

Most of the temporary items were authorized for immediate destruction, while several were to be "destroy[ed] when no longer needed for reference." Since these databases are now more than 40 years old and were retained in 1980 on media no longer used, disposal of all temporary records is assumed to have taken place.

EVALUATION

Item 1. National Police Infrastructure Analysis Subsystem I: Gazeteer

Recommendation: Destroy immediately.

<u>Description:</u> A geographical description of South Vietnam, both GVN and VC controlled, basic for the uniform construction of the National Police Files.

Evaluation: This gazeteer for subsystem I is duplicated by a gazeteer for subsystem II, which will be used as documentation for both.

Item 2. National Police Identification Followup Subsystem.

Recommendation: Destroy immediately.

<u>Description:</u> and was used by the National Police Force to plan countermeasures.

Evaluation: The data is duplicated in the NPIASS-II subseries which has been recommended for accession.

Item 3. VNAF Personnel Automated Accounting System (tapes 2, 3 and 4)

Recommendation: Destroy immediately.

Description: These tapes are unreadable. Tapes 2,3 and 4 are described in Item #16. Evaluation: These tapes are unreadable. ------

Item 4. Weekly Intelligence Estimate Update System.

Recommendation: Destroy immediately.

- <u>Description:</u> An automated record of enemy attacks and friendly activities resulting in contact involving Regional and Popular Forces.
- Evaluation: Data is duplicated in the Territorial Forces Activity Reporting System, which is accessioned and available to the public.

Item 5. Force and Material Reporting System.

Recommendation: Destroy immediately.

- Description: Provides unit strengths, location and logistics information for all units in strategic reserve or otherwise not stationed in-country, but under the command of MACV headquarters. It was used to plan for emergency deployment, redeployment and withdrawal actions.
- Evaluation: This series has extremely limited coverage (February to May 1972.e) It has relevance only to the planning for the eventual United States withdrawal from Vietnam in 1973. There are no historical or statistical reasons to accession this series.

Item 6. Aircraft Inventory System.

Recommendation: Destroy immediately.

- <u>Description:</u> A system to keep track of aircraft (not known which or how many) in Vietnam to forecast scheduled maintenance and to maintain an up-to-date inventory. (December 1972 to February 1973).
- Evaluation: Information is on data systems maintained in the United States, which will be eventually offered for accession to NNR. In addition to being duplicated in other files, there is insufficient documentation to use the file. Finally, it has extremely limited coverage.

Item 7. Central Munitions System.

Recommendation: Destroy immediately.

- <u>Description:</u> Included ammunition assets by place and unit, receipts, transfers and expenditures. (1965-1972).
- Evaluation: Though potentially a valuable data base that would provide a record of ammunition expenditures and other logistical information, four input tapes provided little or no data and the two data files were missing at the time of the inventory.

Item 8. Medevac Control Roster System.

<u>Recommendation:</u> Destroy immediately.

<u>Description:</u> Provides personnel information on all medical evacuees leaving Vietman for medical treatment. (January 1967 (est) to December 1972.e)

Evaluation: Potentially a valuable tool which could be linked to other personnel and casualty lists, the data on the tape received only one quarterly report of 3,434 evacuees out of a possible 70,000 for the entire period.

Item 9. Operation Keystone Requirements.

Recommendation: Destroy immediately.

<u>Description:</u> Contains technical items of equipment stocked by American supply depots that could be turned over to the South Vietnamese armed forces. (August 1970 to October 1972).

Evaluation: The data tape received with this series was blank.

Item 10. MACV Joint Table of Distribution System.

Recommendation: Destroy immediately.

Description: An automated construction of the make-up, by positions and spaces, of the MACV headquarters. (September 1968 to February 1973)e

Evaluation: This small series (2572 records) can be linked with other data concerning the US buildup of forces in 1965 and the eventual "drawdown" of forces in 1973. Military historians could compare the assumption of responsibilities within the headquarters commensurate with the size of the personnel involved. It would also contain "friendly order of battle" information. Unfortunately, it has been written in a data base management system and would be of little benefit to researchers without expensive and time-consuming reformatting procedures in NNR.

Item 11. Procurement Agency Vietnam Master Contracts Roster System. Recommendation: Destroy immediately.

Contains information on active, inactive and retired contracts issued or administered by the U.S. Army Contract Administration Office, Vietnam. Lists contractors, contract value, effective dates, how funded and amount obligated. (November 1971 to February 1973)

Three files were read in this system, but only one approximated the same data elements in a NARS-constructed record layout. This file describes a total of SZO "active" and "inactive" contracts, but does not tape conceivably contains the retired records. One date conceivably contains the retired records. Item 12. Sensor Inventory Control System.

Recommendation: Destroy immediately.

Evaluation:

Description: Managed the inventory and assignment of sensors. These were infrared and other devices that detected inflitration of the enemy along the South Vietnamese borders adjacent to North Vietnam and Laos.

Evaluation: Some information could be obtained about infiltration routes and numbers of infiltrators, etc. There would be very little manipulative value to using a computer for these statistics since they would be duplicated by textual records. Furthermore, the data base is written in a data base management system and would be of little benefit to researchers without expensive and time consuming reformatting procedures by NNR. 
<u>Recommendation:</u> Printout into textual form by Computer Output Microfilm; destroy machine-readable tape after printout.

Description: A machine-readable finding aid to a textual series. (January 1971 to December 1972). See more complete description part two of this appraisal job.

Evaluation: Basic textual series has not yet been offered for accession. This series would be no more useful in machine-readable form, yet much more expensive to preserve. See complete evaluation in part two of this appraisal job.

Item 15. Awards and Decorations System.

- <u>Recommendation:</u> Printout into textual form by Computer Output Microfilm; destroy machine-readable tape after printout.
- <u>Description:</u> Contains all awards given to persons (American, South Vietnamese, Australian, etc) under MACV command. (1971 to 1973) See more complete description in part two of this appraisal job.
- Evaluation: Since its value depends more on individual searches and not machine manipulation, this series would be more useful in textual form. See complete evaluation in part two of this appraisal job.
- Item 16. VNAF Automated Personnel Accounting System (Tape No. 1 only)
- <u>Recommendation:</u> Printout into textual form by Computer Output Microfilm; destroy machine-readable tape after printout.
- Description: Dossiers of all personnel in the Air Force of South. Vietnam. (1971-1973) See more complete description in part two of this appraisal job.
- Evaluation: Since its value depends more on individual searches and not machine manipulation, this series would be more useful in textual form. See complete evaluation in part two of this appraisal job.
