Description:

The Office of Education was established within the Department of the Interior, effective July 1, 1930, by the Department of the Interior Appropriation Act for Fiscal Year 1931 (46 Stat. 281), approved May 14, 1930. The Office was assigned to the Federal Security Agency by Reorganization Plan No. 1 of 1939, July 1, 1939; to the newly created Department of Health, Education, and Welfare (HEW) by Reorganization Plan No. 1 of 1953, effective April 11, 1953. The Office of Education was abolished on May 4, 1980, by the Department of Education Organization Act (93 Stat. 668), October 17, 1979, with functions transferred to the Department of Education.

RECORDS OF THE CIVIL DEFENSE EDUCATION BRANCH, 1959-71. 11 Cubic feet, WNRC Accession Numbers 12-71A0615 and 12-71A7337.

The Civil Defense Education Branch (Division of Adult Education Programs, Bureau of Adult, Vocational and Technical Education, Office of Education in the Department of Health, Education and Welfare) implemented Civil Defense Adult Education program (CDAE) established by the Office of Civil and Defense Mobilization in 1959. The primary task of the CDAE was to teach the principles of individual, family, and community protection in case of a nuclear or natural disaster. The program was implemented by contracting with state Departments of Education who would develop and support a civil defense training capability through adult education resources. The CDAE program worked closely with state school administrators to incorporate the CDAE with the school systems. The program was abolished in 1971.
