DESCRIPTION:

The Department of Education provides national leadership in expanding fundamental knowledge and understanding of education from early childhood through postsecondary study, in order to provide parents, educators, students, researchers, policymakers, and the general public with reliable information about educational practices that support learning and improve academic achievement and access to educational opportunities for all students, the condition and progress of education in the United States, and the effectiveness of Federal and other education programs

The National Center for Education Statistics (NCES) within the Institute of Education Sciences is the primary ED entity for collecting and analyzing data related to education in the United States and other nations. It fulfills a Congressional mandate to collect, collate, analyze and report full and complete statistics on the condition of education in the United States, conduct and publish reports and specialized analyses of the meaning and significance of such statistics, assist State and local education agencies in improving their statistical systems, and review and report on education activities in foreign countries.

Many ED components also collect and maintain data that support analyses, studies, and reports relating to educational issues, trends, and approaches, and methodologies. These collections, analyses, and studies do not have national impact or significance.

Records documenting data collections, analyses, and studies of national impact or significant historic interest are permanent. These records include public and/or restricted datasets, data files, and supporting documentation. Examples include data collections for Longitudinal Studies, High School and Beyond, National Survey of Postsecondary Faculty, Opening Fall Enrollment, Residence and Migration, and Public Libraries.

2 Common Core of Data (CCD) Survey System master data files

The Common Core of Data collects information from states about public school districts and schools for use by the Institute for Educational Sciences (IES). It is a state-level survey that includes all revenues and expenditures for public education (with the exception of revenues and expenditures for the state education agencies). The CCD was implemented in 1990, collecting data on school Year 1988-1989 in its first year of operation. Information is collected annually from school districts about the districts and their member schools. System data includes expenditures from Title I grants (and carryover), expenditures from Title V, Part A grants (and Carryover), average daily attendance, breakout of property tax revenue from non-property tax revenue for dependent school districts, purchased services and supplies expenditures, salary expenditures for enterprise operations, and property (equipment) expenditures by function.

3 Private School Universe Survey (PSS) System master data files

The PSS consists of a single survey that is completed by administrative personnel in private schools. Information collected includes religious orientation, level of school, size of school, length of school year, length of school day, total enrollment (K-12), number of high school graduates, whether a school is single-sexed or coeducational and enrollment by sex, number of teachers employed, program emphasis, existence and type of kindergarten program

4 Schools and Staffing Survey (SASS) System master data files

SASS has four core components, the School Questionnaire, the Teacher Questionnaire, the Principal Questionnaire, and the School District Questionnaire. Data is collected via these questionnaires sent to respondents in public, private, and Bureau of Indian Affairs/tribal schools.

5 Integrated Postsecondary Educatiδη Data System (IPEDS) master data files

IPEDS is a web-based data collection system. The Department's Institute for Educational Sciences (IES) uses IPEDS to collect and store data received from postsecondary institutions from 1987 to the present. System data includes aggregate information on enrollments, completions, finances, graduation rates, and institutional characteristics.

6 National Assessment of Education Progress (NAEP) Database master data files

System information includes nationally representative achievement scores on 4th, 8th, and 12th graders from public and non-public schools in a variety of academic subjects, as well as student background information and information on learning environments

7 National Assessment of Education Progress (NAEP) High School Transcript Study (HSTS) Database master data files

The database includes information on students' coursetaking, course credits earned, grade point average, performance on the NAEP assessment, and student and school background characteristics.

8 National Household Education Surveys Program (NHES) Database master data files

The National Household Education Surveys Program (NHES) database provides descriptive data on the educational activities of the U S population and offers researchers, educators, and policymakers a variety of statistics on the condition of education in the United States. The NHES surveys cover learning at all ages, from early childhood to school age through adulthood. Survey topics include early childhood care and education, young children's readiness for school before- and after-school activities of school-age children, parent and family involvement in education, and adult education. In addition to these topics, NHES occasionally fields surveys on topics of special interest to the Department of Education that are not intended to be repeated, such as civic involvement, library use, and parent perceptions of school safety and discipline.

The system data includes records from the RSA-911 Case Service Report containing employment data about the consumers, Social Security Administration data on receipt and amount of social security benefits, unemployment insurance wage records data, and information from baseline and follow-up surveys about post-VR experiences, particularly related to employment outcomes and post-closure services.
