1. Private Schools and Teachers Survey, 1985-86:

Public use data files and documentation. School data include information on tuition, enrollment, minority enrollment, staffing, advanced placement programs, graduates applying to college and use of aides and volunteers. Teacher data include information on age, sex, race/ethnicity, salary, training, experience, subjects taught, working hours, assistance of aides and volunteers, additional employment, and teacher opinions.

DISPOSITION: PERMANENT. Transfer data files and documentation to the National Archives upon approval of this schedule.

2. Public Schools and Teachers Survey, 1984-85:

Public use data files and documentation. School data include information on enrollment, minority enrollment, staffing, advanced placement programs, graduates applying to college, use of aides and volunteers, use of computers and incentive programs for teachers. Teacher data include information on training, experience, subjects taught, incentives, certification and endorsement, assistance of aides and volunteers, salaries, working hours, additional employment, age, sex and racial/ethnic identity.

DISPOSITION: PERMANENT. Transfer data files and documentation to the National Archives upon approval of this schedule.

3. Schools and Staffing Surveys:

Public use and restricted use data files and documentation, 1987-. Several surveys containing data collected from public and private schools, school administrators and teachers. School data include information on enrollment, staffing, community type, school type, religious affiliation, length of school year and school day, minority students and teachers, support services, tuition, admission requirements, students graduated, experience and education of teachers, new and former teachers, and use of volunteers. Administrator data include information on demographic characteristics, education, experience and perception of school climate. Teacher data include information on demographic characteristics, education, experience, teaching assignment, certification, perceptions of school climate, teacher's job, teaching load, and salary.
