1. National Household Education Surveys (NHES):

Public use data files and documentation, 1991. Public use and restricted use data files and documentation, 1993-. The Early Childhood Education component includes information obtained from parents or guardians on 3- to 8-year-old children about child care and early childhood program experiences, kindergarten and primary school entry, parent involvement in programs and schools, home educational environment and household and family characteristics. The Adult Education component contains information from adult education participants and nonparticipants about adult education courses or activities including course title and content, degree requirement fulfillment, sponsor, employer involvement, payment source, perceived benefits and barriers, and background characteristics of survey participants.

DISPOSITION: PERMANENT. Transfer public use and restricted use data files and documentation to the National Archives upon official release of the file.
