In the case of an exclusion denial, the request, supporting documentation, and associated correspondence may serve as the basis for an appeal to the DOE Office of Hearings and Appeals. Alternative Fuel Transportation Program- Exemption Requests Requests for exemptions from Alternative Fuel Transportation Program (State and Fuel Provider Fleet Program) standard compliance requirements, including supporting documentation and associated correspondence. They include materials detailing information related to vehicle acquisitions and justifications for not acquiring vehicles, based on a lack of available alternative fuel or lack of available vehicle models, including DOE requests for additional information and the information the requestors subsequently submit. In the case of an exemption denial, the request, supporting documentation, and associated correspondence may serve as the basis for an appeal to the DOE Office of Hearings and Appeals. Alternative Compliance Waiver Request Applications Alternative Compliance Waiver Request Applications, for waiver from the Standard Compliance requirements of the Alternative Fuel Transportation Program (State and Fuel Provider Fleet Program) and associated correspondence. They include materials detailing information related to projected alternative fuel use in the upcoming model year, and may also include information related to fleet composition (i.e., vehicles). In the case of a waiver request application denial, the request, supporting documentation, and associated correspondence may serve as the basis for an appeal to the DOE Office of Hearings and Appeals.
