1. Unidentified images relating to experiments, publication graphics, and related activities. These records consist mainly of uncaptioned and otherwise unidentified 4" x 5", 2 1/2" x 2 1/2", and 35mm black and white negatives. A few color negatives are present, as are a small number of prints. Included here are shots of experimental animals, laboratory apparatus, magnified cells, bar graphs and charts, lectures, and agricultural activities. The material dates from ca. 1957 to ca. 1981. The volume is approximately 1/2 cubic feet. There is no arrangement. Location: box 1.

3. Identified images of laboratory workers and facilities. These records consist mainly of numbered and briefly captioned 4" x 5", 2 1/2" x 2 1/2", and 35mm black and white negatives. A few color negatives are present, as are a small number of prints. Many of the negatives cite "print numbers". Subject include scenes of laboratory personnel at work, experiment methods and results, and of miscellaneous procedures involving plants and animals. A few images of facility buildings and construction are included. The material dates from ca. 1965 to ca. 1978. Approximately 200 images are present. There is no arrangement. Location: box 2.

Disposition: Permanent. Transfer to the National Archives immediately.
