2. Description: Official copy of the following OSTI publications:
 - o Prestige Collection - These publications were chosen by DOE individual programs to be given full book treatment. They represented the leading edge in nuclear energy related research. Publications included in this collection were:
 - National Nuclear Energy Series (1949-1956)
 - American Society of Metals (1963-1970)
 - American Industrial Hygiene Association Critical Reviews (1966-1972)
 - American Chemical Society Critical Reviews (1975)
 - American Institute of Biological Sciences Critical Reviews (1964-1974)
 - American Nuclear Society Critical Reviews (1963-1978)
 - AEC/ERDA/DOE Critical Review Series (1969-1979)
 - UN International Conferences of Peaceful Uses of Atomic Energy - Atoms for Peace (These were the DOE publications for the Geneva Conferences. (1955, 1958, 1964)
 - AEC/DOE Symposium Series (1962-present)
 - Other monographs which were funded by AEC because they contained leading edge research but did not have a large enough audience to warrant commercial publication.
 - o Educational Series
 - Understanding the Atom (1965-1967)
 - World of the Atom (1965-1967)
 - Educational Pamphlet Series (?)
 - o OSTI Publications
 - Current Awareness Bulletins - These are bibliographies on specific subjects that are produced monthly. (1977-present)
 - Energy Research Abstracts (Index of DOE reports and some foreign reports. Still produced monthly) (1975-present)
 - Nuclear Science Abstracts (Index of nuclear research. This was replaced by INIS Atom Index) (1946-1976)
 - Nuclear Safety (Journal that is produced quarterly) (1959-present)
 - Bulletins, pamphlets, brochures, etc. that promote OSTI and its predecessors, the

databases, or publications.

Appraisal - These publications comprise the record copies of the OSTI publishing history. OSTI is currently working on an archival plan to comply with NARA guidelines that will ensure that the record copies of these materials will be not be lost. Based on this plan, and the approval of this request for Records Disposition Authorization, OSTI will transfer sub-sets of this collection to NARA in accordance with 36 CFR Part 1228.190.

Each sub-set transferred will be accompanied by an electronic index to allow access to the collection. This index will be cumulative and updated for each sub-set transferred to provide a single comprehensive index to the record series.

Based on OSTI's role within the Department of Energy in support of Departmental research activities, the incorporation of this activity into OSTI's current operation, and per guidelines presented in 36 CFR Part 1220, the following disposition is requested:
