The Office of the Federal Inspector for the Alaska Natural Gas Transportation System (OFI) was an independent agency established pursuant to P.L. 94-586, the Alaska Natural Gas Transportation Act of 1976, Reorganization Plan No. 1 of 1979, and Executive Order 12142. (See also OFI Regulations, 10 CFR Ch. XV, Part 1500-1535, 1-1-92 Edition). The OFI began operations July 1, 1979 and was abolished on October 24, 1992 by the Energy Policy Act of 1992, P.L. 102-486, which transferred all functions and authority vested in the Federal Inspector to the Secretary of Energy.

OFI's mission was to expedite the Federal permitting process and oversee the construction and initial operation of the U.S. portions of the Alaska Natural Gas Transportation System (ANGTS), a proposed 4,800-mile natural gas pipeline to bring gas from Prudhoe Bay on Alaska's North Slope south across western Canada to U.S. markets. Phase I, the southern portion of ANGTS, known as the prebuild, comprising 32 percent of the total System and 1,512 miles, was completed. This segment delivers Canadian gas from near Calgary, Canada, to Stanfield, Oregon in the Western Leg and to Ventura, Iowa in the Eastern Leg.

In 1982, due to energy market conditions, the Alaska and Canadian Leg sponsors suspended operations on Phase II, the northern sections of ANGTS. OFI, in response to this project hiatus, curtailed its operations, reduced its staff, closed its field offices and, in 1985, affiliated with the Department of Energy for administrative convenience and coordination purposes.

From 1985-1992, OFI continued to monitor events affecting ANGTS including the U.S. and Canadian sponsors plans to expand and extend Phase I to bring additional supplies of Canadian gas to U. S. markets; and to follow developments concerning the Trans-Alaska Gas System, a competing gas pipeline that would export North Slope natural gas to Pacific Rim countries as liquefied natural gas.

In January 1992, the Federal Inspector recommended in a report to President Bush that OFI be abolished. No funding was proposed for OFI in FY 1993 and the majority of FY 1992 funds were rescinded by P.L. 102-298, the FY 1992 Rescission Act, signed by President Bush on June 4, 1992.

OFI Headquarters was located in Washington, D.C. and its field offices were in San Francisco, CA (Western Leg-closed in 1982), Omaha, Nebraska (Eastern Leg-closed in 1983), Irvine, CA (Engineering Office-closed in 1985), Fairbanks, AK (Alaska Leg-closed in 1984) and Anchorage, AK (Alaska Leg-closed in 1986).

From 1979 to 1985, OFI maintained two separate filing systems: central (chronological) files and working (subject) files. The central files included incoming and outgoing documents, OFI correspondence and internally generated documents. Documents were assigned a document identification number and supported by an index (on microfilm). The working files were structured individually by each program/field office and arranged by subject matter. OFI microfilmed its central and working files from 1979-1985. Working (subject) files in hard copy remain for 1985-1992. The microfilm contains both an original negative and a positive copy. At the time of filming, the microfilm was not certified as to archival standards. There is some duplication of documents in the microfilm and hard copy files.

b. Microfilmed files from 1983-1985. Correspondence and memoranda filed chronologically by Document ID number, not supported by an index, of the Irvine, CA Engineering Office and the Alaska field offices.  
Disposition: PERMANENT. Retire to WNRC. Transfer to the National Archives 1 January 2012. (This material may be exempt from public disclosure under FOIA, 5 USC Sec. 552.) Individual rolls whose contents consist entirely of transitory, duplicate and/or GRS-covered material may be destroyed during archival processing.
