## 2. Clinical Training Payback Files -

These records are maintained within the three ADAMHA institutes, including the National Institute of Mental Health, National Institute on Drug Abuse, and the National Institute on Alcohol Abuse, and Alcoholism.

Disposition - Close file when all payback requirements have been fulfilled or formally waived. Transfer files closed in one fiscal year to Federal Records Center one year later. Destroy files six years after close of files.
