These titles have been analyzed by the Motion Picture Sound and Video Branch, National Archives and Records Service, for material with possible historical interest. These are being offered to the National Archives on a separate SF258. The remaining 157 titles are without such interest. An integral part of the agreement with EPL Pathology Archives to obtain the historical items and, at the same time, to avoid three years' storage charges on the 228 cans on the part of the Government is to obtain a release for disposition of the 228 cans so that EPL can recover its storage space for other commercial use. This SF115 is being processed is being processed to facilitate that disposition and to obtain the historical items without cost.
