Background Information           National Responsible Fatherhood Clearinghouse (NRFC) Website is Congressionally mandated, and is authorized under the Claims Resolution Act of 2010 (as codified under 42 USC 603(a)(2)(C) (IV)) to serve as a national repository for responsible fatherhood information. The NRFC is designed to promote and encourage the appropriate involvement of fathers in their children's lives. The NRFC Virtual Collaborative Community (VCC) is a critical component of the NRFC to allow fatherhood stakeholders from across the United States (grantees and non-grantees) to engage in peer-to-peer learning and support to help these practitioners collaborate and discuss common issues, challenges and promising practices, and strategies to resolve problems. The VCC is an authentication based online platform that allows authorized members to share information and research content with liked missioned individuals and groups that share the same passion and focus on fatherhood within the broader community.
