## Trafficking Victims Tracking System (TVTS)

Item # Trafficking Victims Tracking System (TVTS) Collects, stores, and maintain information regarding victims of severe forms of trafficking in the United States for the purposes of issuing certification (for adults) and eligibility (for children) letters that make them eligible to apply for Federal benefits and services to the same extent as refugees

### 1 TVTS Database Records

This information is used for the purposes of issuing certification (for adults), eligibility (for children) letters, and to prepare and publish various statistical reports. Data includes victim identifying information, such as names, DOB, country of origin, gender, type of trafficking, and Alien number, as well as name and business address of victim's case manager. Information may be provided and collected to track types of services for which victims applied, including NGO provider information and type(s) of benefits.

**Disposition: TEMPORARY** Cut off at the end of the fiscal year in which certification or eligibility is issued. Retain for a minimum of 10 years after cutoff or when no longer needed for business purposes, whichever is later.
