1.	<p><u>THE ELDERLY POPULATION: ESTIMATES BY COUNTY</u></p> <p>Computer tapes containing estimates of the population 60 years and older and 65 years and older for every county of the United States as of July 1, 1976 and July 1977 and for successive years. In addition, the tapes contain estimates for approximately 600 Planning and Service Areas (PSAs) which consist of single counties or groups of counties and cover the entire nation. The Bureau of the Census created the files for the Administration on Aging using data from the 1970 decennial census and current Medicare enrollment files. Its purpose was to provide State and Area Agencies on Aging with current estimates of the size of their target population in order that these agencies may plan and evaluate their programs more effectively.</p> <p>Present accumulation: 2 reels of tape. Anticipated annual accumulation: 1 reel of tape.</p> <p>Disposition: Disposable. Transfer to the Center for Machine-Readable Records, Machine-Readable Archives Division, National Archives and Records Service. Review every five years.
