Background Information

The Federal Select Agent Program is jointly comprised of the Centers for Disease Control and Prevention/Division of Select Agents and Toxins and the Animal and Plant Health Inspection Service/ Agriculture Select Agent Services. The Federal Select Agent Program oversees the possession, use and transfer of biological select agents and toxins, which have the potential to pose a severe threat to public, animal or plant health or to animal or plant products. The Program greatly enhances oversight by:

Developing, implementing, and enforcing the select agent regulations to help ensure this research is conducted in a safe and secure manner.

Providing oversight of possession to ensure that the U.S. government has full awareness of entities in lawful possession of these potentially dangerous biological agents and toxins.

Conducting inspections and approving registrations in order to make sure that appropriate measures are in place at each registered entity to prevent the unauthorized access, theft, loss, or release of select agents and toxins.

Approving individual access to select agents and toxins to help guard against access by bioterrorists or any others who may wish to misuse the agents. All individuals who work with select agents and toxins must first undergo a security risk assessment performed by the FBI.

Receiving reports of a theft, loss, or release of a select agent or toxin to understand and help reduce risks posed by the situation, ensure proper action is taken and appropriate authorities have been notified, and help the entity identify ways to prevent it from happening in the future.

Taking appropriate enforcement actions for regulatory violations to address the risk and increase future compliance with the regulations.

Serving as a resource on compliance with the regulations by providing guidance, trainings, and outreach to help entities meet the requirements of the regulations.

Collaborating with domestic and international partners to assist others with the development and implementation of appropriate biosafety and security oversight programs.

In addition, CDC's Division of Select Agents and Toxins (DSAT) oversees the Import Permit Program. The CDC Import Permit Program (IPP) regulates the importation of infectious biological materials that could cause disease in humans in order to prevent their introduction and spread into the U.S. The program ensures that the importation of these agents is monitored and that facilities receiving permits have appropriate biosafety measures in place to work with the imported agents.

Disposition Authority Number DAA-0442-2019-0001-0003

Applicants will enter their own information through a secure portal and immediately submit the form directly to IPP for review and approval. Provides a centralized location where applicants can get status updates. Applicants will receive real-time information on the status of the permit. Users will be able to pull information previously submitted through IPP to use for new applications. Provides applicants with a historical record of permits. Moving forward, applicants will be able to find details on past permits issued, expiration dates, etc. Applicants will be able to communicate with the program through a two-way portal for submitting and sharing information.
