2. Magnetic tapes submitted by individual states which which contain data encoded from original reports of induced termination of pregnancy. Data is checked for error rate against a sample of original reports and then used to build the vital statistics detailed data-tape files.

Authorized Disposition: Erase or return tapes 1 year after close of year of coverage or after successful validation and merging of data into master file, whichever is sooner.

B. Detailed data-tape Files on ~~Abortion~~ Data (Currently only 14 States providing data) including certificate numbers

1. Unedited Version containing complete data for each incident, plus related documentation.

Authorized Disposition. erase or destroy in 3 years or when no longer needed.

2. Edited ~~Public Use~~ Data Tape containing neither certificate numbers nor specific geographical codes for locations having populations of less than ~~250,000~~ 100,000, plus related documentations.

Authorized Disposition: Permanent - produced annually; ~~offer~~ to the National Archives, 5 years after the data tape transfer is available. users will be informed of but do not have to sign a data use agreement.

Purpose of this Request: To schedule a series of records collected by NCHS National Vital Statistics Registration System which were omitted from the NCI-90-81-4 Records Schedule.
