IMPAC II (Information for Management, Planning, Analysis, and Coordination) is the successor to NIH's original IMPAC information management system. This is a central extramural data system administered by the Office of Extramural Research (OER). It contains initial review group actions, council actions, awarding unit actions, and other individual grant information taken from applications, awards, and other grant and contract records. The data is used for preparing publications, listings, and tabulations, administrative purposes such as fiscal operations, budgeting, and program planning, public information and responses to inquiries; and research analysis. Included are records contained in systems interfacing with IMPAC II for administrative and tracking purposes. Also included are records documenting the establishment of new activities and new activity codes (C R 6304-2 and C R 54101) (Manual Chapters 54101 and 6304-2).
