Item 1 AHRQ National Guidelines and Quality Measures Clearinghouses (NGC/NQMC)

The National Guidelines and Quality Measures Clearinghouses is a database and web site that provides information on evidence-based clinical practice guidelines and health care quality measures and measure sets in a searchable format. AHRQ editors summarize evidence-based clinical practice guidelines and health care quality measures provided by various third parties. The NGC/NQMC also allows users to compare specifications of guidelines and measures in the NGC/NQMC system.

(Note: NGC/NQMC web content is scheduled under the AHRQ web schedule, N1-510-09-12.)

- a) Master file: Includes links to full-text clinical practice guidelines and health care quality measures, summaries of clinical practice guidelines and health care quality measures that meet explicit criteria, information about external resources relating to clinical practice guidelines and health care quality measures, a glossary of terms, and expert commentary articles about matters of import relative to clinical practice guidelines and health care quality measures, as well as associated public comments.

Disposition: TEMPORARY. Cut off at the end of the calendar year in which information in the resource is published to the public. Delete 3 years after cutoff or whenever no longer needed for business purposes, whichever is later.
