MASS serves as a data repository and analysis tool created to support the execution of the statutory missions of the United States Coast Guard, and achieve Maritime Domain Awareness (MDA) as part of the National Strategy for Maritime Security. MASS collects and compiles a broad range of records information on ports and port facilities, maritime vessels and vessel characteristics.
