**Item 1**

The MAGNET system receives data from various DHS and non DHS source systems, standardizes the information, and correlates the information to build a Maritime Domain Awareness (MDA) tool for Coast Guard and other authorized personnel. The primary user interface created by MAGNET is a map indicating ship names, movements, and other basic information as it appears in a given geographic area.

The MAGNET system also allows users to query the system using either pre-stored, parameterized queries or queries built ad hoc by the users. Authority for maintaining records: Federal Records Act of 1950, Title 44 U.S.C. 3101; Title 36, Code of Federal Regulations, chapter XII; The Maritime Transportation Security Act of 2002, Pub L. 107-295 The Homeland Security Act of 2002, Pub L.107-296; 5 U.S.C. 301; 14 U.S.C. 632, 33 U.S.C. 1223, 46 U.S.C. 3717, 12501.

**MAGNET replaces an existing integrated intelligence sharing system known as the Joint Maritime Information Element (JMIE) Support System (JJS). Records are maintained in electronic format.**

**Records Descriptive**

Records containing information on maritime vessels and vessel characteristics including: performance data, vessel identification data, vessel registration data, current ship position, crew back ground, passenger lists, port history, cargo, known criminal vessels, and suspect lists.

**MASTER FILES**

- a. Audit Files: All records provided to a MAGNET user in response to a "specific name" query and records documenting access to specific individuals.

**Temporary**

**Cut off at the end of the calendar year in which the query is conducted. Destroy records 5 years after cutoff.**

- b. Records on vessel position(s) and movement(s).

**Temporary**

**Cut off at the end of the calendar year in which the record is created. Destroy records 10 years after cutoff.**

- c. Records on vessel(s) port history, cargo, characteristics, identification status, crew(s), performance data, vessel(s) registration data, known criminal vessels, suspects list, and audit records.

**Temporary**

**Cut off at the end of the calendar year in which the record is created. Destroy records 20 years after cutoff.**
