The proposed schedule covers U. S. Secret Service documentary and training motion picture film. These films are used for personnel training and include the mission and organization of the Treasury Department, and the U. S. Secret Service, as well as film documenting the protective and investigative mission of the Service.

The attached inventory lists fifty-eight motion picture reels of film concerning training and/or documentary topics currently being retained by the Office of Government Liaison and Public Affairs (OGLPA). These reels have been examined by the Service's Archivist and representatives of the Policy Analysis and Records Systems Branch, Management and Organization Division.

Some of the inventoried film is over thirty years old. For example, the film entitled "Vice President Henry Wallace in South America, First Freedom" was produced around 1934 to 1936. These older films need to be stored in a controlled environment due to deterioration and emission of chemical vapors. This deterioration process can result in spontaneous combustion. Therefore, it is recommended that all reels over 30 years old be assessed as permanent records and immediately be transferred to the National Archives for retention and proper processing. The remaining reels may be retained in the Service's possession for up to thirty years from the date of production or until the deterioration process warrants transfer.
