The results of the investigation did not result in a trial or criminal charges, but were significant enough that Louis O. Guiffrida, Director at that time (1985), did resign his position.</p> <p>The Agency considers these records to be permanent since they generated much publicity and notoriety within the Congress, media and the public. <u>I.G.
