The maps were claimed by the Defense Civil Preparedness Agency by direction of the Secretary of Defense, effective May 5, 1972. The maps and overlays detail the projected effects of wind currents, time, distance from blast, megatonnage of bombs and altitude of detonation upon the amount of radioactive fallout on major industrial and military centers in the United States.</p> <p>Closed Series: 144 cu. ft.</p> <p>Disposition.
