Background Information

The Explosives Operations Division (EOD) provides an expert, rapidly deployable, national level resource that conducts all aspects of transportation explosives security for the United States and foreign governments. The Division provides technical explosives subject matter expertise and support to all directorates of TSA, manages the Transportation Security Specialist – Explosives (TSS-E) program consisting of over 4,000 TSS-Es in 143 locations, and functions as the TSA Senior Explosives Officer and Senior Advisor to the Assistant Secretary on all explosives issues. The Explosives Operations Branch further divides into the following two (2) sections:

Strategic & Technical Program: Manages and coordinates the headquarters technical explosives programs and functions, including security and research and development programs; explosives engineering; explosives technology integration; plans/policy and intelligence liaison; and representation at TSA, DHS, and interagency explosives working groups. The section further reviews and coordinates all headquarters technical explosives responsibilities and serves as the headquarters primary Go-Team representation for National Safety Transportation Board and Federal Bureau of Investigation Explosives Unit requests for technical support during transportation system investigations involving the suspected or actual use of explosives.

Operations Section: Provides program management for the field TSS-E program responsible for developing and executing budget, recruiting, training, and qualification of field TSS-Es, coordinating their operational deployment in support of assigned missions, and managing the branch's outreach program with TSA elements and external stakeholders.

Supporting Authorities: Aviation and Transportation Security Act (Public Law 107-71); The Homeland Security Act of 2002 (Public Law 107-196); Homeland Security Presidential Directive 19, "Combating Terrorist Use of Explosives in the United States"
