Background Information           The Transportation Security Redress Branch (TSRB), part of the Civil Rights and Liberties, Ombudsman, and Traveler Engagement Division, of the Transportation Security Agency, is the Executive Agent of the Department of Homeland Security Traveler Redress Inquiry Program (DHS TRIP). DHS TRIP provides redress to those applicants whose name and other information resembles that of someone on a watch list through the use of a Redress Control Number (RCN), which is linked to the Cleared List. A passenger with an RCN on the Cleared List, barring other factors such as random selection, is able to travel without screening difficulties. Data related to the redress request and the requester are stored in the Office of Transportation Security Redress system (OSTR) Redress Management System (RMS) system.

TSA is requesting authority to increase the retention period for records related to cleared travelers to up to 99 years so that cleared travelers will not need to request redress every 7 years, as would be the case under the current retention period.
