Background Information

Pursuant to Title 49 U.S.C. § 114, the Transportation Security Administration (TSA) is responsible for security in all transportation modes. TSA incorporates a variety of different layers of security measures to identify and mitigate threats to aviation security, as well as other modes of transportation. TSA Law Enforcement/Federal Air Marshal Service (LE/FAMS) Special Mission Coverage (SMC) is the intelligence-driven, risk-based deployment of Federal Air Marshals (FAMs) on flights when individuals have been identified as posing a higher risk to security. Multiple sources of intelligence, from within TSA, as well as other Government agencies, are leveraged to identify individuals who may pose a potential risk to aviation security and result in these targeted SMC FAM deployments.

The FAM team completes After Action Reports (AARs) with pertinent observations made during the passenger's travel following the completion of their assignment. During SMC assignments, FAM teams may refer to the information documented on previous AARs.

1	<p>Special Mission Coverage: Enhanced and Limited After Action Reports (AARs)</p> <p>Disposition Authority Number DAA-0560-2019-0013-0001</p> <p>Where an SMC FAM team is assigned on account of particularized information indicating that a specific passenger, or passengers, pose a higher risk to transportation or national security, such as matches to the No Fly or Selectee Lists of the Terrorist Screening Database, LE/FAMS uses the Enhanced AAR to document the SMC assignment. Additionally, where an SMC is assigned on account of an intelligence-driven, risk-based analysis of the passenger's travel or other data submitted as part of their international travel, and a FAM team observes suspicious or criminal activity during travel which may lead to a referral to another agency for appropriate investigative follow-up, LE/FAMS seeks to retain these AARs consistent with the procedures for its maintenance of Enhanced AARs. Where an SMC is assigned on account of an intelligence-driven, risk-based analysis of the passenger's travel or other data submitted as part of their international travel, LE/FAMS uses the Limited AAR to document the SMC assignment. While TSA assesses these passengers to pose a higher risk to aviation security, subjects of these subsets of SMC assignments do not meet the reasonable suspicion standard for being a known or suspected terrorist, and typically are not the subject of an ongoing investigation. The Limited AAR solicits information regarding the activities during their travel only to the extent that the FAM team observes potentially suspicious or criminal activity. Unless suspicious or criminal activity is observed during travel warranting such notification, these reports are not shared with law enforcement or intelligence partners.</p> <p>Final Disposition Temporary</p> <p>Item Status Active</p> <p>Is this item media neutral?
