


1600 – Maritime and Land

EXIS – The system was designed to provide maritime transportation security communities nationwide with scenario based exercises, evaluations, and accompanying information technology products. Specifically, EXIS is a web-based application developed to provide security training exercises that include a mix of basic tabletop, advanced tabletop, and functional exercises, and capture the associated lessons learned, corrective actions, and best practices while strengthening the Nation's ability to prevent, respond to, and recover from a transportation security incident.

1. **Item: Master/Database:** Includes user profile information, exercise templates, user created community information and exercise packages
 - a(1). **Community Creator User Profiles:** Those user profiles that have created at least one user community within the system

TEMPORARY Cutoff at the end of the calendar year **Destroy/delete** 10 years after cutoff
 - a(2). **All other user profiles:** Those profiles that, while active, did not create any communities within the system

TEMPORARY Cutoff after 1 year of inactivity or termination of account **Destroy/delete** 3 years after cutoff
 - b. **Exercise Packages:** Includes scenarios, feedback, guides and similar documents maintained in case files specific to individual registrants

TEMPORARY Cutoff at the end of the calendar year **Destroy/delete** 10 years after cutoff
 - c. **Communities:** Allow users to view and share information among a subset of EXIS members, by grouping exercises and key exercise data under a private sub-site within EXIS. Access is restricted to Community members and controlled by designated Community Managers
