| 1. | <p align="center">US Customs Service Automated Commercial System (ACS)</p> <p>Entry Summary System</p> <p>The Entry Summary System (ESS) is a relational table-based data base within the US Customs Service (Customs) Automated Commercial System (ACS) that allows agency personnel to review and process entry summaries for products, produce, raw materials, and other goods entering the US. ESS captures the required data enabling Customs to assess duties, taxes, and fees, collect statistics, and determine if legal and regulatory requirements are met. This system supports entry summary review, anti-dumping/countervailing duty, quota/visa, liquidations, collections, drawback, and protest functions.</p> <p><i>cc Agency, NARA</i></p> | | |

US Customs Service Automated Commercial System (ACS)

1. Entry Summary System (ESS)

- A. Master Files** – Includes tables of closed entry summary data such as Archived Entry Summary Header (CLB) – that contains information identifying date and place the entry was filed, the importer, the surety company and bond information, and total duties, taxes, and fees; Archived Entry Summary Header Extension (EX4) – that contains additional header information (not all CLB file records will have matching EX4 records), and Archived Entry Summary Line Detail (ENC) – that contains information identifying the commodity imported by classification number, country of origin, country of export, date of export, manufacturer, and duties, taxes, and fees for the line. Dates: 1987 – 1992

PERMANENT. Transfer data to the National Archives upon approval of this schedule in format that complies with 36 CFR 1228 270 or otherwise approved by the National Archives.

- B. Master Files** – Includes tables of closed entry summary data such as Archived Entry Summary Header (CLB); Archived Entry Summary Header Extension (EX4); and Archived Entry Summary Line Detail (ENC). Dates: 1993 – Present

PERMANENT. Cut off at end of calendar year. Transfer data to the National Archives 9 years after cutoff.

- C. Documentation** – Contains the data dictionary for the Entry Summary Archive (ENX), Archived Entry Summary (CLB), Archived Entry Detail Line (ENC), manuals, and other related documentation

PERMANENT. Transfer to the National Archives with associated Entry Summary System master files upon approval of this schedule and with subsequent transfers of Entry Summary System Master Files transfers to the National Archives.

The National Archives and Records Administration may dispose, without further permission from the US Customs Service, duplicative, fragmentary, nonrecord materials, and items covered by the General Records Schedules
