1.	<b>THE STUDENT AND EXCHANGE VISITOR INFORMATION SYSTEM (SEVIS)</b>  <b>Description.</b> The Student and Exchange Visitor Information System (SEVIS) is an internet-based system that provides tracking, monitoring, and access to accurate and current information on non-immigrant Students (F-1 and M-1), exchange visitors (J-1), and their dependents (F-2, M-2, and J-2) in the United States. The system is an E-gov environment with the main repository at the Justice Data Center in Rockville, Maryland.  SEVIS enables schools and program sponsors to transmit electronic information and event notifications via the internet to the Department of Homeland Security (DHS) and the Department of State (DOS) throughout the stay of a student or an exchange visitor in the United States. The system will reflect international student or exchange visitor status changes; such as admission at Port of Entry (POE), change of address, program extensions, and in programs of study. SEVIS also allows printing of appropriate forms and provides reminders, alerts, and basic reporting capabilities.  <i>cc Agency, DHS</i>	NCI-85-85-1  And NCI-96-1/3d	

SEVIS enables schools to submit school certification applications, submit updates to DHS that require adjudication, and create and update the records of F-1 (academic) and M-1 (vocational) students and their dependents. DHS officers have the capability to adjudicate updates made to school and student records using SEVIS, and Principal Designated School Officials (PDSOs) will be notified through SEVIS of the adjudication results.

**Program:** Student Exchange Visitor Program (SEVP)

**Applicability:** Agency-wide

**Specific Restrictions:** Highly sensitive tracking and monitoring information as well as confidential information concerning foreign students and their dependents. All records in SEVIS are protected from unauthorized access through appropriate administrative, physical, and technical safeguards. The safeguards include restricting access to those with a need-to-know to perform their official duties, using a permanent ID and password.
