1	BACKGROUND CHECK SERVICE (BCS) Description. The Background Check Service (BCS) is being developed to route, track, store, and consolidate all USCIS background check activities into a centralized system. The system will consolidate previously disparate systems and provide a central web-based interface for adjudicators to submit background check requests and view all background check activity related to a benefit applicant/petitioner. Categories of Individuals Covered By The System: Individuals covered by provisions of the Immigration and Nationality Act (INA) of the United States (e.g. applicants/petitioners for immigration benefits). All applicants/petitioners will have a background check administered before a benefit case is determined.

The BCS will interface with all USCIS benefit application data, the FBI and CBP for Name Check data, and the FBI for Fingerprint data

Program: Office of Field Operations

Applicability: Agency-wide

Specific Restrictions Personally identifiable information and possible law enforcement sensitive information BCS and records contained within are protected from unauthorized access through appropriate administrative, physical, and technical safeguards. The safeguards include restricting access to those with a need-to-know to perform their official duties, using a user ID and password issued by the Password Issuance Control System (PICS)

a. **INPUTS.**

Categories of Records In The System:

The BCS will contain biographical information collected in the process of performing and reviewing background checks (i.e., the process by which USCIS vets an applicant/petitioner for any negative history and verifies applicant/petitioner identity). The records in BCS will be comprised from derived data from USCIS case managements systems (see below) and derived data from the Federal Bureau of Investigation's National Name Check Program, the FBI's Criminal Fingerprint Check and Custom and Border Protection's (CBP) Treasury Enforcement Communication System / Interagency Border Inspection System (TECS/IBIS)

USCIS Case Management Systems providing data to BCS include the

- Computer-Linked Application Information Management System (CLAIMS) 3, which is used to process applications including, but not limited to, an Adjustment of Status (Green Card) and Temporary Protective Status (TPS),
- CLAIMS 4, which is used to process applications for Naturalization,
- Refugee Asylum Parole System (RAPS), which is used to process Asylum applications, and
- Marriage Fraud Assurance System (MFAS), which is used for processing information relating to investigations of marriage fraud
