DESCRIPTION OF ITEM AND PROPOSED DISPOSITION Computer Linked Application Information Management System 3 Local Area Network (CLAIMS 3 LAN) CLAIMS 3 LAN is a case management application used by USCIS to track and process the adjudication of applications and petitions (referred to herein collectively as "applications") for immigration benefits and services except those related to asylum and naturalization. CLAIMS 3 LAN maintains and processes information from numerous different types of USCIS applications and is the primary source of applicants' or petitioners' (referred to herein collectively as "applicants") information that is used to perform background checks, conduct examinations (review of the information that is being provided by applicants), and adjudications (process by which decisions are made to grant or deny an application). CLAIMS 3 LAN collects information that includes data identifying an applicant or beneficiary, information supporting the applicant or beneficiary's claimed eligibility and status, and supplementary supporting or corroborative information. Collection of data takes place at USCIS' five service centers, Baltimore and Washington District Offices, and the Administrative Appeal's Office.	9.
