Background Information Frontsight was a contractor-owned application that allowed Enforcement and Removal Operations (ERO) to track airborne and ground resources in near real-time. It was comprised of two main pieces of functionality, Air Common Operating Picture (Air COP) and Surface Common Operating Picture (Surface COP). Air COP allowed ERO to track flights while Surface COP allowed ERO to track resources on the ground.

Frontsight had data fed to it by the FAA and the Omega travel agency, which ERO used to book all its flights (both for employees and aliens when needed). The FAA fed flight information such as flight times, altitude data, flight plans, and weather while Omega provided the name of the ERO officer(s) on each flight, the name of the alien(s) on the flight, and the alien's A-Number. (Each ERO officer was listed with the A-Number of the alien who he/she was accompanying.) AIR COP brought all this information together on a map of the world. This allowed ERO to track each plane and provide easy access to information on each flight that had recently landed at its destination, that was currently in the air, or that was about to take off.

Surface COP provided users with similar information for ERO resources on the ground. There was a map of the world upon which the users would see ERO resources such as vans, buses, field offices, and detention facilities. GPS provided location-based information on ERO vehicles, including their location and speed, which was then matched to fleet data such as the vehicle's make and model. Together, this static and real-time information allowed ERO to track vehicle movements and the status of ongoing operations. The application also provided basic information about field offices and detention facilities including their location and contact information.

Users could also add resources to the map such as incidents, the location of an operation, infrastructure, etc. in order to keep other users of the system up-to-date as to what was happening in ERO around the world.

ERO Information Technology and Business Transformation conducted a Frontsight Operational Analysis (OA) which justified not continuing the use of Frontsight beyond September 2012. The system was not replaced.

Both static and dynamic data reside on hard disk drives in application and database servers. Static data are data that do not change on a day-to-day basis. Static data relate to field offices and detention facilities and include their location and contact information and fleet information. Dynamic data are real-time data from FAA, Omega Travel, and GPS data feeds that are constantly being updated and are associated with the deportation event or resource being tracked.
