Academy Class Management System (ACMS) is a web based application that supports and processes student training data of U S Immigration and Customs Enforcement (ICE), ICE/Federal Protection Service (FPS), Citizenship and Immigration Services (CIS) organizations and Federal Law Enforcement Training Center (FLECTC) and Customs and Border Patrol (CBP) components of DHS interface with the application

ACMS system provides automation support in the class management areas of planning, organizing, monitoring, controlling, evaluating, and reporting More specifically, the enterprise software is used for scheduling and activation of academy sessions, field observation reporting, registration of trainees, creation of student sections, establishment of groups, assignment of instructors, processing of test and quiz grades, tracking of physical skills training (firearms, drivers training, physical tactics, fitness etc) as well as practical exercises, monitoring of trainee progress, electronic generation of documents/forms/letters/management reports, and for producing a wide range of information needed to manage the Academy's classes
