The U S Immigration and Customs Enforcement (ICE), Law Enforcement Parole Branch (LEPB) Office, within International Affairs (IA) is responsible for the handling of Significant Public Benefit Parole (SPBP) and Continued Presence (CP) cases The Parole Case Tracking System (PCTS) is a windows-based graphical user interface system used by the LEPB to track, maintain and report on individuals participating in the SPBP and CP programs

The Parole Case Tracking System is used to monitor, track and report on SPBP and CP parole cases assigned to individuals paroled into the United States Federal law grants the Department of Homeland Security (DHS) the authority to parole individuals into the United States for the purpose of testifying in criminal trials or involvement in other law enforcement activities


