#### **Electronic Surveillance Database (ELSUR)**

The Electronic Surveillance Database (ELSUR) tracks state and Federal court orders for electronic surveillance conducted by U.S. Immigration and Customs Enforcement (ICE). In a typical transaction, the ELSUR process begins when an agent, ICE or another Federal agent, submits a request for an ELSUR query to identify all previous applications for court authorized intercepts conducted by ICE on the target they intend to name in an application for an intercept. Authorized ICE personnel will then conduct a search in ELSUR for the requested information, if any prior activity exists, it is reported to the requesting agency or ICE agent. The court order approval process begins when an ICE agent submits a request for electronic surveillance (Title III order) to the Assistant U.S. Attorney's (AUSA) office. The request goes through a process of legal review and is sent to a District Court judge to approve or deny. Whether it is approved or denied, the application for intercept is entered into ELSUR. Surveillance information is taken directly from the court order and manually keyed into the database.

Legal Authority Title III of the Omnibus Cnme Control and Safe Streets Act of 1968

The District Court judge will review the application for intercept and decide whether to issue a court order approving electronic surveillance (Title-III order) by the agency. Whether it is approved or denied, the court order information, if available, is entered into ELSUR. The primary data includes

#### B. Input (Media Neutral)

## (1) Request for Indices Checks for Prior Applications of ELSUR Activity (Query Request)

An ICE or other Federal agent can submit a request to search for previous ICE electronic surveillance requests in order to support the preparation of new electronic surveillance requests by ICE and other Federal agencies conducting criminal investigations. The query request contains basic information, such as the subject and target device, and information about the new electronic surveillance request being prepared. The request could be received either in hard copy via fax or electronically via email. ICE uses this information to query ELSUR for any possible matching records.

#### (2) Title III (T-III) Application for Intercept

A "Title III Application" is a package produced by the Special Agent (affiant) and the Assistant US Attorney (AUSA) At a minimum this package contains the affidavit, the unsigned Court Order, and the concurrence of the Department of Justice (DOJ), Office of Enforcement Operations (OEO) The package is presented to the Judge for review and ultimate approval of the T-III

#### C. Output

#### (1) ELSUR Title III Report (Query Report)

When an ICE agent or another Federal law enforcement agency submits a Query Request to the Tech Ops Unit to perform a check for prior applications for activity of surveillance, the ELSUR database is searched to determine if any prior activity exists. If the query is positive, a report identifying the date, duration, district, judge who authorized the intercept of the person, place, or thing, and the specific target of the intercept will be generated. The report will be sent via fax or email to the requesting ICE Special Agent or other law enforcement agency's ELSUR Unit

#### (2) Aggregate Reports

ELSUR also enables users to generate aggregate reports to determine how many indices checks have been processed for a specific Federal agency

\*NOTE: GRS 20, Item 16 authorizes Federal agencies to destroy this type of record when the agency determines that it is no longer needed for administrative, legal, audit, or other operational purposes, provided they do not contain substantive information, such as substantive annotations, that is not included in the electronic records. (Records of this type that contain substantive information should be disposed of in accordance with the NARA-approved schedule that covers the series in which they are filed.) ICE has determined, based upon business needs, these records can be destroyed/deleted five (5) years after their creation.
