Background Information **The Decal and Transponder Online Procurement System (DTOPS) is a public-facing Web-based online procurement system through which commercial vehicle, private aircraft, and private vessel owners can pay a yearly fee, rather than a per transaction charge, to cross the U S border by purchasing yearly user fee decals and transponders DTOPS also supports an intranet site for CBP access to accounts**

The personal data includes names, email addresses, physical addresses, and phone numbers. Vehicle information includes license plate, make, model, year, color, cab number, registered owner, C-TPAT or FAST ID, VIN number, and vehicle status (active or deactivated). Vessel data includes the model year, manufacturer, vessel name, and one of the following: US Coast Guard ID, local registration number, or Hull ID. Aircraft information includes model year, manufacturer, and tail number. The DTOPS system also retains the payment tracking number supplied by the payment processing system Pay.gov. Payment information is not retained within DTOPS. Holders of an active account can purchase a single crossing or yearly user fee to expedite border crossing. DTOPS only captures crossing data for users that have purchased a single border crossing fee in order to track their account status. Crossing data is not captured for transponders since they give users unlimited crossings for a calendar year. The crossing data for single border crossing fees consists of notifications DTOPS receives from ACE (Automated Commercial Environment) as to when and where a vehicle has crossed the border. This data enables DTOPS to determine which accounts have utilized their single crossing fee.
