PNR information is defined as information collected and containing in the air carrier's automated reservation/departure control systems (reservation systems), that describes the traveler's identity and travel itinerary and that of other travelers included under the same reservation record. PNR data is stored in CBP's Automated Targeting System-Passenger (ATS-P).  <u>Data Retention:</u>  EU PNR data will remain in an analytical active database for a period of seven years.  After seven years, the data is moved to a dormant, non-operational status. Data in dormant status will be retained for eight years and may be accessed only with approval from a senior DHS official designated by the Secretary of Homeland Security.  Data related to a specific case or investigation may be retained in an active database until the case or investigation is archived.
