


1. ~~Decal and Transponder Online Procurement System (DTOPS)~~

~~DTOPS is a public-facing Website available for user fee decal and transponder transactions. Commercial vehicles, private aircraft, and private vessels are required by CBP to pay a fee when crossing the U S borders. To satisfy this fee, transponders (radio frequency identification tags or RFID) for commercial vehicles can be purchased for a yearly fee for multiple border crossings. DTOPS is an online procurement application where yearly fee payment can be made. Upon payment, decals will be issued for aircraft and vessels, while transponders are issued for vehicles.~~

Disposition **TEMPORARY** Cut off at the end of the fiscal year in which transponder or decal expires. Delete/Destroy 3 years after cut off.
