Electronic System for Travel Authorization (ESTA)

Electronic system for Travel Authorization is a system which enables foreign nationals of the Visa Waiver Program (VWP) countries may apply for and secure advance authorization to travel to the United States. The system affords CPB the opportunity to vet the applicant before granting the authorization to travel to the United States under the VWP. This information can be shared with other DHS components on a need to know basis.

Disposition. **TEMPORARY.** Cut off at the end of the fiscal year in which ESTA is approved. ESTA authorizations expire and are inactive 2 years after date of approval. Destroy/Delete after 17 years after cut off.
