1	<p>See attached sheets</p> <p>RG-060, DEPARTMENT OF JUSTICE Duplex-Numeric Classification System Class 9, "War Matters" Miscellaneous Unscheduled Records</p> <p>Executive Branch Emergency Powers and Presidential War Powers, D J Number 9-03-1 (1930-1949)</p> <p>The file, consisting of 6 chronological file sections and 5 serialized enclosures, deals with a variety of issues and high-level initiatives related to emergency powers of the Executive Branch and the war powers of the President as the prospect of war grew ominously during the 1930s. Early documentation in the file concerns Public Resolution 98 of the 71st Congress that established a "War Policies Commission" to consider a universal draft and to study how to equalize the burdens and minimize the profits of war, as well as the policies to be pursued in the event of war to enable the President to mobilize all the resources of the country. The Commission consisted of high-level members of the Executive Branch (such as Hoover Administration Secretary of War Patrick Hurley and Attorney General William DeWitt Mitchell), members of Congress (such as Senators Arthur Vandenberg and</p>

3	<p>States sold some 6,442 patents to The Chemical Foundation. The suit, which eventually went to the Supreme Court, was a government attempt to set aside the sale of a number of these patents wherein the government alleged that the Chemical Foundation had fraudulently conspired to obtain the seized alien property patents at a nominal price without any public advertisement from the Alien Property Custodian. The courts ruled that the sale was valid. A modest volume of material for this case has already gone to the National Archives in College Park: 10 sections, 14 folders, 2 "special folders," and enclosure serial numbers 1-15 in WNRC accession 060-53-0050, boxes 156-159, and enclosure serial numbers 16-23 in WNRC accession 060-62-0532, box 42 (6 inches).</p> <p>Disposition: PERMANENT. Transfer to WNRC immediately. Transfer to National Archives in the year 2010.</p> <p>Miscellaneous Class 9 General File Enclosures</p> <p>A. Two enclosure files for D J Number 9-01-1 (1928-1933)</p> <p>These two enclosures contain copies of proposed legislation concerning property seized by the Alien Property Custodian during World War I: H R 7201 (12/13/1927) concerning the resolution of claims from German and American nationals for return of property held by the Alien Property Custodian, H R 7201 (02/21/1928) for the same purpose, and S 876 (03/29/1933) for an extension of time to file claims under the Settlement of War Claims Act of 1928. The files include only reference copies of the legislation, they contain no comments on the bills nor any additional substantive information concerning them (1 inch).</p> <p>Disposition: Transfer to the WNRC immediately and destroy in the year 2010.</p> <p>B. One enclosure file for D J Number 9-01-3 (1939)</p> <p>This enclosure includes reference copy translations of pertinent Austrian and German citizenship laws in the litigation of Helene Weiss v. Frank Murphy, CIV-2277, D D C. The suit itself (D J Number 9-17-9-10081, the file for which went to the National Archives at College Park in WNRC accession 060-53-0050, box 134) concerned Helene Weiss's eligibility for return of seized property based on a determination of her citizenship under German and Austrian law and her residence in Czecho-Slovakia before and after German occupation. Original copies should be in the Weiss litigation case file cited above. An additional file for D J Number 9-01-3 previously transferred to the National Archives at College Park in WNRC accession 060-70-3747, box 12 (1 inch).</p> <p>Disposition: Transfer to the WNRC immediately and destroy in the year 2010.</p>
