| | <p align="center">Attorney Search Warrant/Attorney Subpoena Systems</p> <p>Because of potential effects upon attorney-client relationships that may result from issuance of a search warrant or subpoena for issues relating to an attorney's representation of a client, there are special authorization procedures in place to govern the issuance of these. These procedures are detailed in title 9 of the U.S Attorney's Manual (USAM). The Criminal Division serves as the authorizing entity for these special search warrants and subpoenas. The Attorney Search Warrant System is an application designed to track various attorney search warrant applications authorized by the Department of Justice. The Attorney Subpoena Network Tracking System is an application designed to track various attorney subpoena information authorized by the Department of Justice.</p> <p align="center">SEE ATTACHED</p> | | |

Department of Justice: Criminal Division: Attorney Search Warrant/Attorney Subpoena Systems

1. ~~Inputs~~

Information is manually input into the system from applications and supporting documentation received.

Disposition: File hard copy documents with related case files and apply appropriate case file disposition.

File instructions only

2. Master files

a. Attorney Search Warrant

The system records data about the requestors (such as the district, agency, contact information), proposed search date, location and type of search, targeted attorney/firm, objectives, relative statutes. Authorization data tracked includes assigned employees, actions, status, and remarks.

b. Attorney Subpoena

Data includes case name, district, agency, requestor information, type of subpoena, violations and statutes, targeted attorney and law firm information, type of information requested, whether they have been notified and will comply, and justifications. Authorization data tracked includes assigned employee, activities and actions taken, status, and remarks.

Disposition: TEMPORARY, delete 10 yrs after date closed.

3. ~~System Documentation~~

Disposition: TEMPORARY, ~~destroy when superseded or obsolete~~-(GRS 20)

4. ~~Outputs~~

The system allows authorized users to produce ad hoc reports as needed.

Disposition: TEMPORARY, destroy/delete when no longer needed for business.
