## Office of Review Settlement Memoranda

The Office of Review evaluates settlement offers in light of litigating potential and policy considerations, furnishes advice and assistance to the trial sections in complex cases, takes final action on settlements within its authority, and advises the Assistant Attorney General on settlements that require final action at a higher level. The Office of Review also assists in resolving disagreements between the litigating sections and the IRS, so that the positions of the Tax Division and the IRS remain constant.

The Office of Review was created following, and because of, the criminal indictment and conviction of a Tax Division Assistant Attorney General from the Truman Administration for conspiracy to defraud the United States, and for bribery involving his official duties
