### 2 Public Report of Debtor Audits by the USTP

The USTP publishes reports detailing the aggregate information about audits conducted in Chapter 7 and Chapter 13 bankruptcy cases. Aggregate results provided in the reports may include, but are not limited to, total audits conducted, aggregated outcomes, judicial district breakdowns of data. This report is distributed via the USTP public website.

### 3 Criminal Referrals by the USTP

The USTP publishes reports submitted to Congress annually detailing the aggregate information about referrals of potential criminal activity in bankruptcy cases. Reports include number and types of referrals, outcomes, and UST activities to prevent bankruptcy fraud. Hard copies are distributed to members of Congress and an electronic copy is provided via the USTP public website.
