2. **Background Files**

Correspondence, memoranda, reports, press releases and other documentation created and acquired in the course of developing regulations and procedures to implement the Radiation Exposure Compensation Act. Documents are filed in three-ring binders, arranged by subject in reverse chronological order. Topics include regulations and revisions, legislation and budget, legislative history, personnel, medical information, general information, miners, downwinders, administration and resources, and comments on regulations.

a. Records relating to budget, administration, and personnel. Volume is approximately one cubic foot.

Disposition: Temporary. Destroy upon termination of program.

b. All other files. Volume is approximately four cubic feet.

Disposition: PERMANENT. Transfer to the National Archives upon termination of program.
