This SF 115 represents a disposition request for the Radiation Exposure Compensation System, (RECS), an electronic records system maintained by the Department of Justice, Civil Division, Torts Branch.

ITEM 1a. Radiation Exposure Compensation System (RECS).

This item consists of a database containing information about persons who applied for compensation under the Radiation Exposure Compensation Act of 1990 (PL 101-426, as amended by PL 101-510), and the actions taken on each application. Files within the system include the Radiation Exposure Compensation Claim Master File (RCPRA), Radiation Exposure Compensation Claimant Master File (RCPCL), Radiation Exposure Compensation Claimant Attorney File (RCPCA), Radiation Exposure Illness File (RCPRI), Location of Radiation Exposure File (RCPRP), Radiation Exposure Source of Proof File (RCPPS), Radiation Exposure Actions File (RCPAC), and Radiation Exposure Payment Transaction File (RCPAS).

DISPOSITION: **PERMANENT.** Maintain on line until the termination of the program (October 14, 2012). At that time, transfer a copy of this database to the National Archives.

NOTE: Transfer should be made in accordance with 36 CFR 1228.188, or its successor.

ITEM 1b. RECS Related Documentation.

This item consists of table descriptions, file layouts, code books and other related documentation needed to understand the database. This includes all materials (electronic or paper) necessary to use the records.

DISPOSITION: **PERMANENT.** Transfer to the National Archives at the same time as the related data in item 1a.
